4.6 - Only Hardware tested in compliance with the regulations as referred to in page one, according to the declaration of the manufacturer is covered by this certificate.


4.7 - The equipment, once installed on board ship, is to be tested in accordance with the above referred Regulations under the supervision of a Society's Surveyor.
