4 Execution of the tests

The tests were carried out on the samples which are representative of the model series specified in 2 above.

The dust test for the degree of protection IP6X was made by suction according to Categorie 1, The depression amounted to 2kPa; the test period was 8 hours.

The test for the degree of protection IP5X was made without suction according to Categorie 2.



5 Test results
